GENERAL ORDER NO. RR - 19

IN RE: REPORTING RAILROAD ACCIDENTS/INCIDENTS TO THE COMMISSION

- A. Each railroad operating in Alabama shall, immediately after reporting an accident/incident by telephone to the Federal Railroad Administration, report such accident/incident to this Commission by telephone when the accident/incident occurred in Alabama. This report shall be made orally at (334) 242-5980. The report shall include the information required by the Federal Railroad Administration under Title 49 of the Code of Federal Regulations, part 225.
- B. Each railroad operating in Alabama shall submit to this Commission copies of all written reports to the Federal Railroad Administration pursuant to Title 49 of the Code of Federal Regulations, part 225, for accidents/incidents occurring in Alabama. These copies shall be sent, on the same day the reports are sent, either:
