- (1) Amend page 2 of Attachment A by eliminating the A.17.4 Unbundled Loop Modification-Additive for the following non-recurring unbundled network elements:
  - A.6.5 2-Wire Asymmetrical Digital Subscriber Line (ADSL) Compatible Loop (nonrecurring w/LMU)
  - A.6.6 2-Wire Asymmetrical Digital Subscriber Line (ADSL) Compatible Loop (nonrecurring w/o LMU)
  - A.7.5 2-Wire High Bit Digital Subscriber Line (HDSL) Compatible Loop (nonrecurring w/o LMU)
  - A.7.6 2-Wire High Bit Digital Subscriber Line (HDSL) Compatible Loop (nonrecurring w/o LMU)

- (2) Amend page 3 of Attachment A by eliminating the A.17.4 Unbundled Loop Modification Additive for the following non-recurring unbundled network elements:
  - A.8.5 4-Wire High Bit Rate Digital Subscriber Line (HDSL) Compatible Loop (nonrecurring w/LMU)
  - A.8.6 4-Wire High Bit Rate Digital Subscriber Line (HDSL) Compatible Loop (nonrecurring w/o LMU)
  - A.13.8 2-Wire Copper Loop-short (nonrecurring w/LMU)
  - A.13.9 2-Wire Copper Loop-short (nonrecurring w/o LMU)
- (3) Amend page 3 Attachment A by eliminating the A.17.4 Unbundled Loop Modification Additive for the following non-recurring unbundled elements.
  - A.14.8 4-Wire Copper Loop-short (nonrecurring w/LMU)
  - A.14.9 4-Wire Copper Loop-short (nonrecurring w/o LMU).

The Order of the Commission entered in this cause on May 31, 2002, as amended by the Errata entered on June 20, 2002, is hereby further amended as noted above. The amendment accomplished herein brings Attachment A of the Commission's May 31, 2002 Order, as previously amended by the Errata of June 20, 2002, in line with the Commission's finding in its May 31, 2002 Order that the Unbundled Loop Modification Additive should be eliminated.<sup>1</sup>
